



Notice of Privacy Practices

This notice contains important information about Stillpoint Acupuncture & Healing Bodywork privacy practices. This notice describes how medical information about you may be used and disclosed, and how you can get access to this information. Please review it carefully.

I. What is this notice? To run my practice, Stillpoint Acupuncture & Healing Bodywork must collect, maintain and use non-public personal information (“NPI”) on patients to whom we provide services. I consider this information private and confidential, and have policies and procedures in place to protect the information against unlawful use and disclosure. This notice describes what types of information as to my legal duties and privacy practices. It also describes your rights to access and control your NPI. I am required to abide by the terms of this notice. However, I may modify the terms of this notice at any time, and the new notice will be effective for all NPI in my possession at the time of the change, and any created or received thereafter.

Information I collect, use and maintain on you at Stillpoint Acupuncture & Healing Bodywork is protected by Federal and State laws: the Health Insurance Portability and Accountability Act (HIPAA) and Michigan State Public Health Law. Stillpoint Acupuncture & Healing Bodywork does not disclose NPI to anyone, except with your authorization or otherwise as permitted by law.

If you believe your privacy rights under HIPAA have been violated, you can submit a written complaint to Stillpoint Acupuncture & Healing Bodywork at the address of the practice. You may also complain to the Secretary of Health and Human Services if you believe your privacy rights have been violated. There will be no retaliation for filing a complaint.

II. What is “non-public personal information” (NPI)? Non-public personal information (NPI) is information that identifies you as an individual and relates to your participation in treatment, your physical or mental health/condition, the provision of treatment or healthcare to you or payment to us for the provision of services provided to you.

III. How we protect NPI? I restrict access to NPI from anyone in my office. I maintain physical and procedural safeguards to protect your information against unauthorized access and use consistent with applicable law.

IV. How does Stillpoint Acupuncture & Healing Bodywork use non-public personal information (NPI) and for what purpose? Here are some examples of what I do with the information I collect and the reasons it might be used.

Treatment: I use information about you to provide medical treatment and services to you ONLY.

Payment: I may use and disclose NPI to obtain payment for the treatment and services you receive. For example, I may disclose your NPI to a third party that may be responsible for the costs, such as a family member who committed in advance and with your approval to be responsible of the treatment cost

Health Care Operations: I may also use and disclose NPI to perform health care operations. This is necessary to make sure that all of my patients receive quality care. For example, I may disclose limited NPI in order to consult with colleagues or other health care professionals.

V. What use and disclosures do not require your authorization? I may use and disclose NPI without your authorization for the following purposes:

As Required by Law: I will disclose NPI when required to do so by federal, state or local law.

Public Health Activities/Risks: I may disclose NPI to public health authorities that are authorized by law to collect information for the purpose of:

- Reporting child abuse or neglect;
- Preventing or controlling disease, injury or disability;
- Notifying a person regarding potential exposure to a communicable disease;
- Notifying a person regarding the potential risk for spreading or contracting a disease or condition;
- Reporting reactions to drugs or problems with products or devices;
- Notifying individuals if a product or device I may be using has been recalled;
- Notifying appropriate government agencies and authorities regarding the potential abuse or neglect of a patient (including domestic violence).

Health Care Oversight Activities: I may disclose NPI to a health oversight agency for activities authorized by law. Oversight activities can include: investigations, inspections, audits, surveys, licensure and disciplinary actions; civil administrative and criminal procedures or actions; or other activities necessary for the government to monitor compliance with civil rights laws and the health care system in general.

Lawsuits and Disputes: I may use and disclose NPI in response to a court or administrative order, if you are involved in a lawsuit or similar proceeding. I may also disclose your NPI in response to a discovery request, subpoena or other lawful processes by another party involved in the dispute, but only if we have made an effort to inform you of the request or to obtain a court order protecting the information the party has requested.

Law Enforcement: I may disclose NPI if asked to do so by a law enforcement official as part of law enforcement activities; in investigations of criminal conduct at Stillpoint Acupuncture & Healing Bodywork or of victims of crime; in emergency situations to report a crime (including the location or victims(s) of the crime, or the description, identity or location of the perpetrator); or when required to do so by law.

Serious Threats to Health or Safety: I may use and disclose your NPI when necessary to reduce or to prevent a serious threat to your health and safety or the health and safety of another individual or the public. Under these circumstances, I will only make disclosures to a person or organization able to help prevent the threat.

Military: I may use and disclose NPI if you are a member of the United States or foreign military forces (including veterans) and if required by the appropriate military command authorities.

Protective Services for the President, National Security and Intelligence Activities: I may use and disclose NPI to federal officials for intelligence and national security activities authorized by law. We may also disclose your NPI to federal officials in order to protect the President, other officials, or foreign heads of state or to conduct investigations.

Worker's Compensation: We may release NPI for worker's compensation or similar programs.

Michigan Automobile Insurance: We may release NPI for Michigan auto insurance claims, as acupuncture is covered for post-accident injuries.

VI. What uses and disclosures of NPI require your authorization?

Individuals Involved in Your Care or Payment for Your Care: I may release NPI to a friend or family member identified by you, that is helping you pay for your treatment or who assists in taking care of you.

VII. What are your rights governing the information that we collect, use and maintain on you?

The Right to Inspect and Copy: You have the right to inspect and obtain a copy of your NPI that we maintain and have in our possession, including treatment records and billing records. If you request copies, I will charge you a fee for the costs of copying, mailing, labor and supplies associated with your request. To inspect and copy your NPI, you must submit your request in writing to my practice address.

Under certain circumstances I may deny your request to inspect and copy your NPI. If you are denied access to this information, you have the right to have that determination reviewed. A licensed health care professional chosen by Stillpoint Acupuncture & Healing Bodywork will review your request and the denial. The person conducting the review will not be the person who denied your request. Stillpoint Acupuncture & Healing Bodywork will comply with the outcome of the review.

The Right to Amend or Correct NPI: If you feel that any NPI I have about you is not correct or incomplete, you may ask us to correct or amend the information. You have the right to request an amendment for as long as the information is kept (seven years) by me. To request an amendment, your request must be made in writing to the practice address. Additionally, you must provide a reason that supports your request.

Stillpoint Acupuncture & Healing Bodywork reserves the right to deny your request for an amendment if it is not in writing or does not include a reason to support the request. In addition, I may deny your request if you ask us to amend information that:

- Was not created by me;
- Is not part of the medical information kept by me;
- Is not part of the information which you would be permitted to inspect and copy; or
- Is accurate and complete.

The Right to an Accounting of Disclosures: An accounting of disclosures is a list of the disclosures I have made, if any, of your NPI.

You have the right to request an accounting of disclosures made by me. This right applies to disclosures for purposes other than those made to carry out treatment, payment and health care operations as described in this notice. It also excludes communications of NPI made to you or disclosures authorized by you.

Your request must be made in writing and state a time period that cannot be longer than (6) years. I may charge you for the costs of providing the list. I will notify you of the cost involved and you may choose to withdraw or modify your request at the time before any costs are incurred.

The Right to Receive Communications of NPI by Alternative Means or at Alternative Locations: You have the right to request that I communicate with you about your treatment and related issues in a particular manner or at a certain location. For example, you may ask that I contact you at work rather than at home. I will accommodate all reasonable requests made in writing.

The Right to Request Restrictions: You have the right to request a restriction or limitation on the NPI I use or disclose about you for treatment, payment or health care operations as described in this notice. You also have the right to request a limit on the treatment information I disclose about you to someone who is involved in your care or the payment for your care (like a family member or friend).

I am not required to agree to your request, however, if I do agree, I will comply with your request until I receive notice from you that you no longer want the restriction to apply.

Any request for a restriction on my use and disclosure of your NPI must be made in writing to the address of the practice. Your request must describe in a clear and concise manner: (a) the information you wish restricted; (b) whether you are requesting to limit my use, disclosure or both; and (c) to whom you want the limits to apply.

The Right to Provide an Authorization for Other Uses and Disclosures: I will obtain your written authorization for uses and disclosures that are not identified by this notice or permitted by applicable law. Any authorization you provide to me regarding the use and disclosure of your NPI may be revoked at any time in writing to the address of the practice. After you revoke your authorization, I will no longer use or disclose your NPI for the purposes described in the authorization, except under the following circumstance:

- I have taken action in reliance upon your authorization before I receive your written revocation

The Right to Obtain a Paper Copy of This Notice: You have the right to obtain a paper copy of this notice of privacy practices at any time.
